I. Introduction and Initial Allegations:

The U.S. Department of Agriculture (USDA), Agricultural Marketing Service (AMS), National Organic Program (NOP) reviews and verifies compliance to the NOP's regulations and standards. On April 16, 2024, the U.S. Department of Agriculture (USDA), Agricultural Marketing Service (AMS), National Organic Program (NOP) received an email complaint alleging that Alexandre Family Farm, located in Crescent City, California, had committed "...many severe animal welfare violations over the past five years...". The compliant also requested that NOP "...investigate CDFA's failure to report any such violations when CDFA was asked to investigate the operation...". As evidence, the complainant linked a 53 page report their organization (Farm Forward) wrote about "Corruption and Consumer Fraud at Alexandre Family Farm."

On April 16, 2024, the NOP searched the USDA Organic Integrity Database (OID) for Alexandre Family Farm and found three results. Alexandre Family Farm was listed a certified by CCOF effective June 26, 2003. Alexandre Family Farm dba Alexandre Kids Eggs was listed a certified by CCOF effective May 02, 2007. Alexandre Family Creamery Dba Alexandre Family Farm was listed as surrendered effective October 17, 2017.

On April 16, 2024, the NOP reviewed its investigation records and found a related investigation NOPC-00009060-23. NOPC-00009060-23 was against the same operation for the same issues. The investigation was closed on September 21, 2023 with the statement "Allegations were not substantiated; complaint was referred to and investigated by the SOP."

• CCOF observed Alexandre's new protocol (b) (4)

Alexandre acknowledged that an animal had been improperly moved with hip lifters.

• CCOF verified (b) (4)

- CCOF and Validus did not observe concerns with body condition score for any animals.
- CCOF confirmed that there was no record that Alexandre neglected a nonambulatory animal and, Alexandre denied this action.
- CCOF confirmed that there was no record of a calf stuck in a headlock with injuries and, Alexandre denied this action.
- CCOF confirmed that Alexandre protocols prohibit cutting teats for any reason.
- CCOF confirmed that there was no record of a cow that was stuck in a feed trough and died.
- CCOF confirmed that Alexandre animals had severe lameness and hoof rot. After the settlement agreement was implemented, CCOF confirmed that Alexandre had implemented a preventative lameness protocol.
- CCOF confirmed that Alexandre transported unfit for transport animals to auction or sale. After the settlement agreement was implemented, CCOF confirmed that Alexandre will complete new forms that comply with the new Organic Livestock and Poultry Standards regulations.

- CCOF confirmed that Alexandre used diesel fuel for fly control. After the settlement agreement was implemented, CCOF confirmed that treated animals were removed from the herd and sold as nonorganic.
- CCOF confirmed that Alexandre did not have tetracycline onsite in 2023 and 2024, and Alexandre denied this action.
- CCOF confirmed that Alexandre does not allow animals to graze near cow
 composting sites and Alexandre is being evaluated by the California Department of
 Agriculture regarding maintenance of natural resources. CCOF confirmed that Alexandre
 is aware of carcass disposal requirements.
- CCOF confirmed that Alexandre animals were without feed and some animals died from trampling. CCOF confirmed that Alexandre implemented new protocols and there has not been a reoccurrence of this type of incident.
- CCOF confirmed that Alexandre has significantly improved their practices and

- Alexandre confirmed that employees were incorrectly moving cows with hip clamps. Employees have been retrained and new protocols are in place to prevent this from happening again.
- Alexandre confirmed that animals were to be horn-tipped in 2019 however some animals were inappropriately horn-tipped. The current protocol is to (b) (4)

 . Additionally, Alexandre has never

used caustic paste for dehorning.

- Alexandre denied that body condition of animals was a concern and that animals were not euthanized due to being too thin for calving.
- Alexandre did not have record of a non-ambulatory cow without care for approximately two weeks however, they did acknowledge that the animal was likely on their property. Alexandre procedures are to (b) (4)
- Alexandre did not have record of a calf stuck in a headlock for approximately three days however they did acknowledge the photo of the animal was from their farm. Alexandre stated that the animal look healthy in the photo and the protocol would be to immediately release the animal.
- Alexandre stated that their protocols have never allowed cutting teats off however, in 2018 or 2019 an individual allowed to be on the farm cut the teat off an animal with mastitis. Alexandre spoke with all employees that may have witnessed the activity and told them that the behavior was not allowed and that it was unethical.
- Alexandre stated that they were not aware of the animal that died in the feed

trough and that the feed manager in the photo was removed in 2018 or 2019.

- Alexandre stated that employees have been trained to trim and treat hooves. They
 have worked with multiple veterinarians for lameness treatment plans. Lame animals are
 treated before they are sold. Alexandre stated that they do not withhold treatment to
 maintain an animal's organic status. Due to their certifiers fall 2023 inspection, they have
 focused on preventative hoof care management.
- Regarding loading unfit for transport and sale animals, Alexandre stated that they had a (b) (4) and determined that this was low for the industry and a testament to longevity in their herd. Alexandre stated that they follow the Beef Quality Assurance Guidelines and the National Dairy FARM Program guidelines for animals leaving the farm. (b) (4)

Alexandre stated that a nutritionist and a veterinarian visit bi-monthly, while each certifying agency visits up to two times per year and their cows were never described as malnourished. Alexandre included a letter from the California Department of Food and Agriculture stating that Alexandre was in compliance with state and federal regulations.

• Alexandre stated that the cancer eye cow that was sold at auction was a healthy cow however she could have gone to auction sooner. Alexandre also stated that there was only one cow in 2023 sold for cancer eye and one cow in 2022 sold for the same reason.

- Alexandre stated that (b) (4)
 , and approved by the certifier. (b) (4)
- Alexandre acknowledged that diesel fuel was used for fly prevention and that treated animals were removed from the herd. Protocols were implemented and training occurred to ensure this does not reoccur.
- Alexandre stated that they had not used tetracycline in over 25 years.
- Alexandre acknowledged that (b) (4)
- Alexandre acknowledged that 30 head, not 40 head, died or were euthanized when there was an equipment break down, staff were unavailable, and animals were held in an area that typically did not hold animals. Alexandre stated that this was a one-time tragic event that resulted in added back up feeding systems, emergency contacts, and new protocols to prevent reoccurrence.

V. Conclusion

Some of the allegations were substantiated by the investigation process and some were not substantiated. Due to systemic failures found at Alexandre, they received a Combined Notice of Noncompliance and Proposed Suspension from their certifier, CCOF. Alexandre changed multiple practices and procedures, trained staff, hired an animal welfare consultant and corrected all noncompliances. Alexandre entered into a Settlement Agreement with CCOF and is receiving additional oversight and monitoring for two years. Alexandre received an unannounced inspection by CCOF in June 2024 and showed correction of substantiated allegations.

VI. Recommendation

The NOP recommends closing this complaint and sending a Case Closure Notice to the complainant, to the certifier, to the California State Organic Program, and to the operation. The notices for each recipient will outline the results of this investigation and put the operation on notice that future violations may result in the suspension of its organic certification per the settlement agreement. Additionally, the NOP recommends opening a Case Management System oversight tracking surveillance to monitor the operation's progress through the settlement agreement process to ensure continued compliance.
